TIME FOR ACTION?

The first AGM in October saw the election of the new executive committee and the completion of the foundation work for FOLK. A report on the AGM and an introduction to the executive committee is on page 2.

Now the work of deciding what we are going to tackle is underway. There have been a number of comments relating to both lack of action and queries about what the group are hoping to achieve. All these issues are covered in our objectives and we now need to turn these into positive plans.

The first two objectives relate to the conservation of the lands and a group of executive committee members are now set up as a working party to help formulate a *Site Management Plan*. They will be using the report already completed by English Nature and will be working in conjunction with Cheltenham Borough Council's own plans. However, there have already been some lively debates about some of the recommendations contained in English Natures report and the money that the Council is planning to spend on preparing a plan rather than implementing it.

As a group we must ensure that all interested parties have an input into the Site Management Plan as it could have a major impact on both conservation and recreation. It will also form the foundation for all future work and action undertaken by FOLK.

The third objective relates to recreational use of the hill. This caused some heated debate at the inaugural meeting, which has since diminished. However, we must be aware that dog walking, mountain biking, horse riding and hang gliding, to name but a few, all have their place on the Hill and Common and must be considered in the future plans of FOLK.

The fourth objective relates to the promotion of public awareness. Some work has already begun on information boards in the hill car parks and we now have a web site which will be an excellent form of communication and promotion. Address at top of page.

The fifth objective relates to consultation with the owners and trustees of the land and we are pleased to welcome David Elsey of C B C onto the committee as an ex officio member. This will speed up communications between both parties.

Whilst the committee will do their best to keep all members informed of developments, it is essential that members inform their committee of their own views. We had hoped to have some letters to publish in this edition, but to date none have been forthcoming.

First Annual General Meeting

The following is a brief summary of the First Annual General Meeting held at 7 pm on 23rd October, 2000 at Leckhampton Primary School.

Present: Approximately 90 members were present together with Simon Lee, Hear of Parks and Landscape Department and David Elsey, Community Parks Officer both of Cheltenham Borough Council.

The Chairman hoped that members would find the meeting interesting and take the opportunity to express views on matters concerning them. He thought that the Friends had got off to a good start. The committee had considered many aspects of the tasks facing the Friends. Now that the society had held its first annual general meeting it was going to be vital that all members should be fully consulted over any activities or policies that the newly elected committee may wish to propose.

Secretary's Report: The interim committee had met four times since the inaugural meeting and had considered many matters including some of the following:

- The site management plan for the Hill as produced by English Nature for Cheltenham Borough Council. Paul Hackman from English Nature addressed one committee meeting. It was clear that there would be a need for a Friend's general meeting to discuss these matters.
- Planned and carried out a site visit accompanied by Geoff Jenkins to become aware of the main features and problem areas.
- Organised a walk for members on 10th September 2000.
- Organised scrub clearance working parties under the guidance of Cotswold Warden and Committee Member, Allan Wood.
- Committee member Judy Frazer-Holland had attended a demonstration of brushcutters and other machinery.
- Promoted organisation membership of the Friends which now included Gloucestershire Society for Industrial Archeaology, British Horse Society, Friends of Naunton Park, 'Cheltenham and County Cycling Club, Shurdington Parish Council, Southfield Manor Park Residents Association and Malvern Hang Gliding Club.
- The need for monitoring the pressures on the Hill and to survey the current variety of users.
- The need to organise a programme of events and activities for the benefit of members.

Any other business

Simon Lee introduced David Elsey, Community Parks Officer. His background win Countryside management. He would be the link between the Friends and t Council and sit as the ex officio member of the Friends Committee.

In answer to a question about the budgeting for management of the Hill Simon I said that £15000 had been allowed for the development of a site management pl but that none of it had been spent so far and it is possible for the full amount to carried over to the following financial year. The Friends would be fully consult over how a management plan would be implemented. It was hoped that an agree plan would be developed over the next 18 months.

In answer to a question about grazing on the Hill Simon Lee stated that no monhad been allocated for fencing at present.

Andy Gilbert asked for reassurance that the Friends would be fully consulted or any developments. He hoped that the Friend's Newsletter could be used as a use forum for discussion in this respect.


Allan Wood reported on the scrub clearance activities (see Page 4). Allan announce that the Cotswold Wardens will be working on Charlton Kings Common during December.

A question was raised about the need for a signboard for the Devil's Chimney many visitors had difficulties in finding it.

Members generally indicated that they did not wish developments to go in direction Crickley Hill. It was accepted that some management would be required. Andy Gilbert suggested that members submitted to him items for the newslett. These might include matters concerned with proposals for managing the Hill.

The chairman concluded the general discussion by saying that the committee I planned to set up a working party (sub-committee) to consider the Site Managem Statement in detail and produce a report. The new committee would make thi matter of some priority.

The meeting ended at 9.05 pm.



CONSERVATION

Bird Observation on Leckhampton Hill.

A favourite walk taken regularly over the last seven years by my wife and myself has been a circular one covering the lower slopes on the north and east sides. It provides good bird watching as well as good exercise for ourselves and our dog. We walk up Old Bath Road, turn left into Pilford Road, climb the style and ascend to Daisy Bank. Turning left along Daisy Bank we eventually reach the T junction where the track from Sandy Lane runs towards Seven Springs. We then turn right along this old track through Charlton Common for about ½ a mile before turning back and descending to Sandy Lane and thence home.


This walk provides a diversity of habitat and a very good variety of birds. Starting with the sloping field between Pilford Road and Daisy Bank, the scrub, hawthorn and blackberry bushes provide regular sightings of Goldfinch, Bullfinch, Greenfinch and Chaffinch. In spring and summer incoming migrants include many Warblers, particularly Chiffchaff, Whitethroat, Lesser Whitethroat, Blackcaps and the (so-called) Garden Warbler. All of these find this habitat very suitable for nesting.

In winter one can see flocks of Redwings and small numbers of Linnets and Redpolls. Along Daisy Bank itself and into Charlton Common, Spring / Summer arrivals include good numbers of Willow Warblers and Chiffchaffs. However, the real highlights are the chances to see and hear Tree Pipitts and Grasshopper Warblers. Both species are rare local breeders and the importance of the Hill for these birds is established in County Records. Usually several Tree Pipitts can be seen perching on small saplings on the slopes above Daisy Bank and Charlton Common. They then rise a bit like a Skylark, singing as they go, before "parachuting" down to the ground. Usually just one or two Grasshopper Warblers skulk in the scrub and shrub at the lower part of the slopes, but the male courts the female by singing his almost endless "recling" song which is sometimes described as the noise made by reeling in a fishing line. Sadly their numbers continue to decline nationally.

Raptors can be seen regularly. Sparrowhawks and Kestrels range the lower slopes and Buzzards soar and glide along the edge. The latter pick off some of the many rabbits, whilst Kestrels hunt smaller mammals and the Sparrowhawks look for unprotected fledglings.

The descent to Sandy Lane shows up the more usual garden birds such as Dunnock, Robin, Blackbird but in one glorious year (1996) a site close to Sandy Lane was occupied by a pair of Nightingales. The male's beautiful song could be heard day and night and the pair successfully raised 2 young. Other unusual highlights have been Waterrail, resident on a tiny trickle of water near Sandy Lane for 6 weeks (1995), Stonechat at Southfield Manor for a week (1999), Woodcock below Daisy Bank (twice in 1998) and the rare Tree Sparrow between Pilford Road and Daisy Bank (December 1998).

Many other birds can be regularly seen including both Green and Great-Spotted Woodpeckers, Jays, Little Owls, Tawny Owls, Song Thrushes, Mistle Thrushes, Yellow Hammers and Spotted Flycatchers. In all we have recorded over 65 species on these northern and eastern slopes and have passed the more interesting records to the County Recorder. Whatever the season there are always good reasons to carry a pair of binoculars on this walk.



HISTORY

We thought we must tell you about an excellent new book called 'Leckhampton', in the 'Britain in Old Photographs' series. This book has recently been produced by the Leckhampton Local History Society and contains 220 old pictures of Leckhampton, together with much historical information. It is a must for anyone interested in the area.

Chapters are devoted to the old village, the newer areas, the Court, churches, the Hill, the Naunton Park area, the rural scene, sports and leisure activities and local people. The book is the result of 3 years work collecting, copying and researching the photographs, most of which were lent or given by local people. The co-authors are Alan Gill and Eric Miller and the book, published by Suttons, is on sale in the local shops and main bookshops for £9.99.

HELP!

VOLUNTEERS REQUIRED - Scrub Clearance on the Hill.

We have already had 3 working parties on the hill to begin the task of clearing the grassland areas of encroaching scrub. However we need many more volunteers. It is proposed to continue the work on the 4th Sunday in the months of January, February and March 2001. There will not be a work party in December. This work cannot usually be carried out beyond March as this will disturb nesting birds.

You may well ask why clear the scrub. If we do not, it will eventually colonise all remaining open limestone grassland areas and result in the loss of a very important and scarce wildlife habitat. Some large areas of scrub will be left as this in itself provides an alternative habitat. We will be clearing pockets of grassland and retain small clumps of scrub and single trees within these areas.

The work is currently being done by hand but we are actively investigating the possibility of using machinery on the more difficult sites. With this in view it is hoped to arrange a machinery demonstration in December. At this stage the hire charges would seem prohibitive but we may be able to attract additional funding for this purpose.

Our work parties meet at the Tramway Cottage car park in Daisy Bank Road at 2:00 pm. Some tools can be provided but, if possible, please bring secateurs, loppers and gloves. No experience is required and you can work at your own pace for as long as you wish. Instruction will be given on the day. Do try and join in for an enjoyable and vital task.

The dates arranged are: Sunday 28th Jan, Sunday 25th Feb and Sunday 25th Mar.
